Rules of Procedure

The Management of Camping Adamello recommends its guests the observance of the following rules in order to ensure a quiet and comfortable stay.

- 1. For the entry and stay in camp is mandatory recording of each individual. Upon arrival, the guest is required to file a proof of identity, to check the accuracy of the records and to promptly notify any discrepancy or variation. The minimum stay is 3 days in high season. Pets are allowed.
- 2. The visits of relatives and friends must be agreed with the management. Persons admitted are required to file an identification card at the entrance. If the stay in camping exceed 60 minutes, will be applied to every person, regardless of age, the rate of List. Visitors not permitted on Saturdays, Sundays and other holidays. The visits are not never permitted during the hours of silence.
- 3. The pitch is chosen by the host. It permitted the installation of only one crew for pitch. Additional equipment may be installed only after ascertaining the availability of space for the car. If during your stay you wish to change the pitch, you must give inform the Management before making the move.
- 4. The counting of the days is done based on the number of nights. the departures must take place before 11.00 a.m. for the pitches and by 10.00 a.m. for the units; beyond this time will be charged an additional day of stay. The payment of the account living room can also be made the day before departure.
- 5. Guest who will give up without booking a minimum notice of 45 days, we will keep the deposit. It admits the arrival delay of 24 hours. Guest who anticipate the start will be counted every day of the reservation.
- 6. Minors must be accompanied by parents or older people who are guarantors all intents and purposes over the Executive.
- 7. Guests can use motor vehicles only for entering and leaving the campsite during the permitted hours, never only for travel within the same. The maximum permitted speed is 10 Km / hour.
- 8. From 11.00 p.m. to 7.30 a.m. and from 1.00 p.m. To 2.30 p.m. is required the utmost silence. in particular are not allowed:
 - the entry and exit of motor vehicles and inside circulation bicycles;
 - the use of plant and equipment, sports and leisure.
- 9. While ensuring the continuous surveillance of the camp, the Department assumes no responsibility for the loss of values and / or personal items.
- 10. Communications and messages addressed to the guests will be exhibited on the notice board at the information office. In cases of extreme necessity guests will be notified personally. Guests are kindly requested to collect their mail at the above office. After five days of storage the mail will be returned to sender.

- 11. The electrical power outlets on the field are set at about 3 A. Any attempt to use equipment of higher powers, which typically stoves, heaters, air conditioners, damages the circuit breaker.
- 12. The use of the "grill" is allowed only in the manner and with the weather conditions that do not constitute a hazard or disturbance. It is forbidden to tie ropes to trees, string, wire, or other hammocks.
- 13. The Management reserves the right to modify these rules if they repent the need.
- 14. This regulation is posted at the entrance is inside the camp, is delivered guests on arrival; the entry into camping so constitute acceptance integral.

The management reserves the right of admission and retention.
